



## EMDR Training in Hong Kong, 2010

Eye Movement Desensitization and Reprocessing (EMDR) is a clinical treatment that involves elements from different therapeutic approaches with eye movements or other forms of stimulations which activate the information processing system of the brain. Over 2 million people worldwide were treated successfully. Case reports and controlled studies reported positive results with the use of this treatment.

The EMDR Association of Hong Kong is delighted to announce the next EMDR training which aims to prepare professionals to use EMDR in their practices. There are two parts: Part I for novices and Part II for those who took part I at least six months prior to the coming training, as well as took supervision.

Our trainer is Dr. Gary Quinn from Israel who is a senior trainer of the EMDR Institute USA. Dr. Quinn conducted our previous trainings and has received high ratings from our trainees.

### Pre-requisites:

Part I: Professional level training in a mental health, medical, social work, counseling field, and 2-3 yrs experience in one-to-one counseling.

Part II: In order to be qualified to participate you need to have completed 6 supervision sessions. If you have not completed yet 6 supervision sessions, you still may participate in Part-2 of the training, however, your participation is subject to the following conditions:

(a) You will have to complete the first 3 out of the 6 sessions prior to the training. Please contact Carolyn Neunuebel (tel: 91690667 or [neunuebel@yahoo.com](mailto:neunuebel@yahoo.com)) for supervision sessions dates.

(b) You will have to complete the other 3 sessions within 6 months after the training.

(c) The Certificate of attendance for Part 2 will be issued to you after having completed all 6 supervision sessions.

Part I: 13 - 15 July 2010 (Tues - Thurs), from 9am to 6pm

Part II: 16 - 18 July 2010 (Fri - Sun), from 9am to 6pm

### Training fee:

HK\$3,900 (HK\$3,600 early-bird registration payable on/before 30 Apr 2010)
